The Department of Adult and Higher Education, Ministry of Education is pleased to announce that **the Government of Cuba** has offered **ONE scholarship in Medicine** for the academic year 2020-2021

Therefore, interested 2019 BHSEC (Class XII) cohort of students (**except already selected for in-country & ex-country scholarships**) with minimum of **65% each in Biology, Chemistry and Physics and 55% in English** may apply for the scholarship.

Candidates fulfilling the above mentioned criteria are advised to apply online at www.citizenservices.gov.bt/education-services and follow the link "Ad-hoc scholarship" on or before **23rd March, 2020**

For online application/registration, the following documents must be ready:

- Online approved valid security clearance
- Scanned copy of class X mark sheet-front page only
- Bhutanese Citizenship Identity Card
- Index number of BHSEC 2019

Please note that repeaters and those already selected for any in-country/ex-country scholarships are NOT ELIGIBLE to apply. The Ministry of Education will select the candidates based on academic merit and forward the nominations to the University. The final confirmation of the nominated candidates will be subject to approval of the **Cuban government**.

The Embassy of the Republic of Cuba in India presents its compliments to The Honorable Royal Bhutanese Embassy in India, and has the honor to inform that one (1) Scholarship in Medicine has been approved in the framework of the educational program granted by the Government of Cuba to the Government of the Kingdom of Bhutan for the year 2020-2021.

The requirements to be met by foreign students benefiting from a scholarship to study in Cuba are:

- a. - Be under 25 years
- b. - Be a Senior Secondary or Pre-University graduate.
- c. - The student must come from a family of low economic income, that cannot afford the studies and preferably that come from communities of the interior of the country.
- d. - Certificate of Health with negative HIV tests. In the case of females, it is also required that they have a certificate that ensures they are not pregnant.
- e) - Document stating that he or she does not have a criminal record.

As the selected student **has to reach Cuba between August 12th and 20th 2020**, the necessary documents have to be handed over to this Embassy before June 15th 2020 for checking and due attestations.

The documentation required to be presented at the Embassy for the Student's Record is the following:

1. Copy of the title of Senior Secondary or Pre-University. It should be attested (both languages) by the Ministry of Education, and after by the Ministry of Foreign Affairs of Bhutan.
2. Copy of the Mark lists Certificate to prove the educational qualifications of the last year of the aforementioned Pre-University graduate. It should be attested (both languages) by the Ministry of Education, and after by the Ministry of Foreign Affairs of Bhutan.
3. No-Crime original certificate from the police. It should be attested (both languages) by the Ministry of Justice, and after by the Ministry of Foreign Affairs of Bhutan.
4. A Health original certificate including a statement that the holder is not a carrier of HIV or other infectious diseases, does not suffer from a physical or mental impediment that would prevent exercise of the relevant profession and in case of female candidates, that the holder is not pregnant. It should be attested (both languages) by the Ministry of Health, and after by the Ministry of Foreign Affairs of Bhutan. The certificated should be issued after 3 of June 2020. It means from 90 days bellow before the dated the student will enter to Cuba in order to maintaining it three months validity before they enter to our country
5. The student must submit 10 photos measuring 1 X 1 inches.

The Ministry of Foreign Affairs of Bhutan should present a verbal note in which testify the name, position and the signature of the person or persons authorized to attest the documents on its ministry and one of these persons is the one who should appeared on all the attested documents by its ministry.

On the attested documents by the Ministry of Education, Ministry of Health, Ministry of Justice and after all of them by Ministry Foreign Affairs of Bhutan should appear the name, position and the signature of the person that attested the document. Also on all the documents should appear the stamp of all the concerned Ministries.

The student selected is requested to come to the Embassy for interview and to read, agree and sign the New Career Ballot to be presented to Cuban Authorities, with an included commitment of payment of the return ticket in case of discharge, for whatever reason as well as the Code of Conduct for Foreign students in Cuba.

He or She will also be given a Letter to help with Immigration, Agencies and Airport formalities, the regulations for foreign students in Centers of Higher Education in Cuba (Resolution 26/2012)

All legal and consular procedures at Cuban Embassy will be free of charge. On successful completion of the course, the student receives the following: Diploma, Grade Certificate, Study Plan.
